II. SUMMARY:

The bill creates a pilot project for children in foster care or relative care placement in Alachua and Citrus Counties to provide specialized educational and other support services to those children as well as the foster parents or relative caregivers.

There is a fiscal impact from the bill.

III. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

Several issues that are problematic as they relate to the current system of providing care and services to children in either foster care or relative caregiver placements include the high rate of disruption of these children, the retention of foster care parents, and the lack of support services for these children and their caregivers. There is no program in existence providing the services proposed by this bill.

B. EFFECT OF PROPOSED CHANGES:

Children in Foster Care or Relative Care Placements

The bill creates an educational enhancement project for children who are in foster care or relative care designed to:

- provide a support system for achieving the educational goals of children in out of home care;
- provide a seamless system addressing the home, school and community needs of children in out of home care:
- achieve an integrated service system to meet the specific needs of each child in the program;
- reduce the disruption of children in out of home placements;
- increase the retention of foster parents through increased support and professionalism; and
- provide support for relative caregivers to enable them to better care for children.

The goals of the project would be accomplished by providing for reduced caseloads, increased inservice training and a salary for foster parents, additional support to foster parents and relative caregivers through four family liaison specialists, services to children in foster care or relative placement through educational and other support services provided by the Anchor Center in Alachua County, and training to licensed foster parents and relative caregivers to enhance child-caring skills.

The Anchor School in Alachua County

The pilot is designed to offer a stable school placement for children in out of home care by placing them at the Anchor School in Alachua County for the entire school year, regardless of how many moves the child makes in the foster care system.

The Anchor Center opened in January of 1997. The school is an innovative program for elementary school students developed to help highly mobile students attain academic success. Enrollment at the Center provides these students who have experienced two or more moves in their school career with the stability of a permanent school home. The school is connected by a transportation network to all areas of Alachua County, so students from anywhere within the county can still access the facility.

E. SECTION-BY-SECTION ANALYSIS:

Section 1. Provides that the Department of Children and Family Services develop a pilot project in Alachua and Citrus Counties with licensed child-placing agencies to provide a specialized educational enhancement program for children in foster care placements or relative placements. The pilot would provide:

- reduced caseloads;
- increased inservice training and a salary for foster parents;
- additional support to foster parents and relative caregivers through four family liaison specialists;
- services to children in foster care or relative placement through educational and other support services provided by the Anchor Center in Alachua County; and
- training to licensed foster parents and relative caregivers to enhance child-caring skills.

Every effort will be made for employees of the project to be individuals who are served by the WAGES Program and the pilot is to be operational by October 1, 1999.

Section 2. Provides an effective date of July 1, 1999.
