Subsections (2), (5), (6), (7), and (8) of 11 12 section 212.0515, Florida Statutes, 1998 Supplement, are 13 amended to read: 14 212.0515 Sales from vending machines; sales to vending 15 machine operators; special provisions; registration; 16 penalties.--17 (2) Notwithstanding any other provision of law, the 18 amount of the tax to be paid on food, beverages, or other 19 items of tangible personal property that are sold in vending machines shall be calculated by dividing the gross receipts 20 from such sales for the applicable reporting period by a 21 22 divisor, determined as provided in this subsection, to compute 23 gross taxable sales, and then subtracting gross taxable sales from gross receipts to arrive at the amount of tax due. The 24 divisor is shall be equal to the sum of 1.0665 for beverage 25 26 items, 1.0645 for beverage and food items, or 1.0659 for other 27 items of tangible personal property, except that for counties with a 0.5 percent sales surtax rate the divisor is shall be 28 29 equal to the sum of 1.0686 for beverage and food items or 1.0707 for beverages and other items of tangible personal 30 property, 1.0686 for food items; for counties with a 0.75 31 1

The certificate 23 must affirmatively state that the purchaser is a vending machine operator. The certificate shall initially be provided 24 25 upon the first transaction between the parties and by November 26 1 of each year thereafter. 27 (b) A penalty of \$250 is imposed on any operator who fails to comply with the requirements of this subsection or 28 29 who provides the dealer with false information. (5) (5) (6) The provisions of this section do not apply to vending machines owned and operated by churches, synagogues, or nonprofit or charitable organizations exempt pursuant to s. 212.08(7)(z). (6) (7) In addition to any other penalties imposed by this chapter, a person who knowingly and willfully violates any provision of this section commits a misdemeanor of the second degree, punishable as provided in s. 775.082 or s. 775.083. (7) (7) (8) The department may adopt rules necessary to administer the provisions of this section and may establish a schedule for phasing in the requirement that existing notices be replaced with revised notices displayed on vending machines.
