1 2 An act relating to Metropolitan Dade County; providing for the relief of Ana 3 4 Quintana-Marquez and Juan Marquez, her husband, 5 for injuries and damages sustained as a result of a collision with a Metro-Dade police car; б 7 providing an effective date. 8 9 WHEREAS, on November 6, 1996, a Metropolitan Dade 10 County police car, while in pursuit of a traffic offender, made an illegal turn at the intersection of N.W. 25th Street 11 12 and N.W. 67th Avenue in Dade County, and the police vehicle 13 collided with an automobile that was being driven by Ana 14 Quintana-Marquez, and 15 WHEREAS, as a result of the collision, Ms. Quintana suffered severe injuries, including blunt abdominal trauma, 16 17 anterior chest and upper extremity contusions, multiple fractures, and two perforations of her colon which were so 18 19 severe that they necessitated a colostomy and subsequent surgery that removed her entire colon and part of her small 20 intestine, and 21 22 WHEREAS, Ms. Quintana has been in pain from the time of 23 the accident forward, has sustained extensive scarring and embarrassment as a result of the accident, and has been 24 rendered unable to participate in normal daily interaction 25 26 with her two toddlers, as well as being rendered unable to 27 perform other normal daily activities such as swimming and easily going up or down stairs, and 28 29 WHEREAS, mediation between Metro-Dade County and Ms. Quintana took place on April 20, 1998, and produced an 30 agreement to settle the matter for \$575,000, and 31 1 CODING: Words stricken are deletions; words underlined are additions.

1 WHEREAS, the county subsequently approved that 2 settlement and, on May 18, 1998, the parties entered into a 3 stipulation of settlement embodying the mediation agreement, 4 and 5 WHEREAS, the stipulation of settlement specified that 6 the county would, by May 28, 1998, pay to Ana Quintana-Marquez 7 and Juan Marquez, her husband, the sum of \$200,000, which is 8 the statutory limit payable without a claim bill, and 9 WHEREAS, the remaining sum payable to Mr. and Mrs. Marquez is \$375,000, NOW, THEREFORE, 10 11 12 Be It Enacted by the Legislature of the State of Florida: 13 14 Section 1. The facts stated in the preamble to this act are found and declared to be true. 15 Section 2. Metro-Dade County is authorized and 16 17 directed to compensate Ana Quintana-Marquez and Juan Marquez, her husband, in the amount of \$375,000 out of funds of the 18 19 county not otherwise appropriated, for injuries and damages sustained as a result of a collision between a Metro-Dade 20 police car and a vehicle operated by Ms. Quintana. 21 22 Section 3.
