I. SUMMARY:

HB 671 creates the Florida Commission on Federal and State Agricultural Relations within the Department of Agriculture and Consumer Services. The purpose of the 16-member commission is to coordinate the efforts of federal and state agencies to identify, seek out, and assist local agencies in maximizing the amount of federal funds obtained for agricultural purposes in Florida.

In FY 1997-1998, the department received \$11,397,650.36 in federal funding for various programs, studies, and disaster relief.

The bill provides for the composition and duties of the council, an annual report, and reimbursement for travel and per diem for council members.

There will be expenses associated with reimbursement of travel and per diem, up to a maximum of \$10,000 for the commission, per year.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

The Department of Agriculture and Consumer Services (department) currently employs a Federal/State Relations Director who monitors opportunities for federal grant support for agriculture and economic development in the state and prepares grant requests, as directed, to gain access to federal funding. In FY 1997-1998, the department received \$11,397,650.36 in federal funding for various programs, studies, and disaster relief. The following chart indicates the uses for these monies.

B. EFFECT OF PROPOSED CHANGES:

This bill creates the Florida Commission on Federal and State Agricultural Relations within the Department of Agriculture and Consumer Services. The commission shall be composed of 16 members, as follows:

- 2 members of the Florida Senate, appointed by the President of the Senate,
- 3 members of the Florida House of Representatives, appointed by the Speaker of the House of Representatives,
- 2 residents of the state who are engaged in the agricultural business, appointed by the President of the Senate,
- 2 residents of the state who are engaged in the agricultural business, appointed by the Speaker of the House of Representatives,
- 2 residents of the state who are engaged in the agricultural business, appointed by the Governor.
- 2 residents of the state who are engaged in the agricultural business, appointed by the Commissioner of Agriculture,
- and the Commissioner of Agriculture shall request 2 members of the United States Congress and the state executive director of the Farm Services Agency of the United States Department of Agriculture.

Those authorities making appointments shall consult with one another to ensure a diversity of agricultural business interests are represented on the commission.

The members representing agricultural business interests shall be appointed to 4-year terms and the Commissioner of Agriculture shall serve as chair of the commission. All members shall serve without compensation, but may be reimbursed for travel and per diem up to \$10,000 per year total for the commission.

The bill provides that the Commissioner of Agriculture shall annually report to the President of the Senate and the Speaker of the House of Representatives on the actions of the commission.
