## I. <u>SUMMARY</u>:

This bill contains the following transportation facility designations:

-Codesignates a portion of State Road 54 in Pasco County as the "State Trooper James Crooks Highway."

-Designates the Florida Highway Patrol substation on State Road 52 in Land O' Lakes as the "State Trooper James Crooks Substation."

-Designates a portion of U.S. 90 in Jefferson and Leon Counties as a part of the "Florida Arts Trail."

-Designates a portion of U.S. 98 in Franklin County as the "Camp Gordon Johnston Memorial Highway."

-Designates the "Charles B. Costar, Sr. Turnpike Plaza" in Palm Beach County.

-Designates U.S. 27 as the "Claude Pepper Memorial Highway."

-Designates a portion of State Road 710 in Palm Beach County as the "Moroso Memorial Highway."

-Designates a portion of Southwest 8th Street in Miami as the "Dr. Armando Bucelo, Sr. Way."

-Designates the Destin Bridge at East Pass on U.S. 98 in Okaloosa County as the "William T. Marler Bridge."

-Designates a portion of the Sawgrass Expressway in Broward County as the "Trooper Donald Earl Jennings Highway."

-Designates a portion of State Road 9 in Dade County as "Carrie P. Meek Road".

-Designates the State Road 292 bridge over Bayou Chico in Pensacola as the "Bayou Chico Bridge".

The Department of Transportation (DOT) will erect suitable markers for the bill's designations, except the FHP substation designation for which the Department of Highway Safety and Motor Vehicles will erect markers.

The bill has a minimum fiscal impact to the state of approximately \$9,600 for the erection of markers. The actual fiscal impact will depend on the number of markers required to appropriately designate each transportation facility.

#### II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

- B. EFFECT OF PROPOSED CHANGES:
  - A segment of State Road 54 (1 mile on either side of Interstate 75) in Pasco County is codesignated as the "<u>State Trooper James Crooks Highway</u>." This designation is contained within the segment of State Road 54 which is currently designated as the "Purple Heart Highway."
  - 2. The Florida Highway Patrol substation on State Road 52 in Land O'Lakes is designated as the "State Trooper James Crooks Substation."
  - 3. U.S. Highway 90 in Jefferson and Leon Counties between Tallahassee and Monticello is designated as part of the "Florida Arts Trail."
  - 4. U.S. Highway 98 in Franklin County between the Tillie Miller Bridge in Carrabelle and the Ochlockonee Bay Bridge is designated as the "Camp Gordon Johnston Memorial Highway."
  - 5. The Palm Beach Plaza on the Florida Turnpike in Palm Beach County is designated as the "Charles B. Costar, Sr. Turnpike Plaza."
  - 6. U.S. Highway 27 in Florida is designated as the "<u>Claude Pepper Memorial Highway</u>." Because of the length of the highway designated, DOT is authorized to determine appropriate intervals along U.S. 27 for the location of markers to inform the public of the designation.
  - 7. State Road 710 (Bee Line Highway) in Palm Beach County between State Road 809 (Military Trail) and State Road 706 (Indiantown Road) is designated as the "Moroso Memorial Highway."
  - 8. Southwest 8th Street in Miami between Southwest 67th Avenue and Southwest 70th Avenue is designated as the "Dr. Armando Bucelo, Sr. Way."
  - 9. The Destin Bridge at East Pass on U.S. Highway 98 in Okaloosa County is designated as the "<u>William T. Marler Bridge</u>."
  - State Road 869 (Sawgrass Expressway) in Broward County between State Road 816 (Oakland Park Boulevard) and State Road 870 (Commercial Boulevard) is designated as the "<u>Trooper</u> <u>Donald Earl Jennings Highway</u>."
  - 11. State Road 9 from Northwest 58th Street to County Line Road (Dade/Broward) is designated as the "Carrie P. Meek Road."
  - 12. The new bridge over Bayou Chico on State Road 292 in Pensacola/Escambia County is designated as the "Bayou Chico Bridge."

DOT is directed to erect suitable markers for the bill's designations, except the FHP substation designation for which the Department of Highway Safety and Motor Vehicles will erect markers.

D. FISCAL COMMENTS:

The bill has a minimum fiscal impact to the state of approximately \$9,600 for the erection of markers. The actual fiscal impact will depend on the number of markers required to appropriately designate each transportation facility. The minimum impact is based on an assumption that at least two markers are required for each road and bridge designation, and at least one marker is required for each building designation. Assuming a cost of \$400 per marker, the State Transportation Trust Fund will incur at least \$9,200 as the cost to DOT for erecting markers. Erecting a marker for designating the Trooper James Crooks Highway Patrol Substation will cost the Department of Highway Safety and Motor Vehicles approximately \$400.

Unless otherwise specifically provided for, the effect of each designation is usually construed to only require the placement of markers for each designation. These transportation facility designations are generally intended for honorary or memorial purposes, or to distinguish a particular facility; local governments and private parties are not directed by the bill to change street signs, mailing addresses, or "911" system listings.

#### VI. AMENDMENTS OR COMMITTEE SUBSTITUTE CHANGES:

The bill as originally filed contained the designations of the "State Trooper James Crooks Highway" and the "State Trooper James Crooks Substation." The other designations were added by amendments adopted by the House Committee on Transportation at its March 11, 1999 meeting. The bill as amended was reported favorably as a committee substitute.

On April 9, 1999, the Transportation & Economic Development Appropriations Committee added one amendment which named a bridge on State Road A1A in Ft. Lauderdale the Commodore Brook Memorial Parkway.
