- (d) When recommending instructional materials for use in the schools, each committee shall require, when appropriate to the comprehension of pupils, that materials for social science, history, or civics classes contain the Declaration of Independence and the Constitution of the United States.

No instructional materials shall be recommended by any committee for use in the schools which contain any matter reflecting unfairly upon persons because of their race, color, creed, national origin, ancestry, gender, or occupation.

Section 5. Subsection (2) of section 233.34, Florida Statutes, is amended to read:

233.34 Use of instructional materials allocation; instructional materials, library books, and reference books; repair of books.--

(2) Each school district shall use the annual allocation for the purchase of instructional materials included on the state-adopted list. No less than 50 percent of the annual allocation shall be used to purchase items which will be used to provide instruction to students at the level or levels for which the materials are designed. However, up to 50 percent of the annual allocation may be used for the purchase of instructional materials, including library and reference books and nonprint materials, not included on the state-adopted list and for the repair and renovation of textbooks and library books. However, such funds may not be used for the purchase of instructional materials for subjects including, but not limited to, science, math, history, and health which do not include historical data related to the contributions of African Americans, Hispanics, and women. Notwithstanding the provisions of this subsection, school districts may use 100 percent of that portion of the annual allocation which is designated by the district for the
