I of the State Constitution.

- (b) Portions of meetings or proceedings of the State

- (4) All information and records acquired by the State Child Abuse Death Review Committee or a local committee are confidential and not subject to subpoena, discovery, or introduction into evidence in any civil or criminal proceedings or to a public records request, except that information, documents and records otherwise available from other sources are not immune from subpoena, discovery, or

introduction into evidence from those sources solely because they were presented to or reviewed by a committee.

- (5) The State Child Abuse Death Review Committee and local committees may share with each other any relevant information regarding case reviews involving child death which information is made confidential and exempt by this section.
- (6) Any person who violates this section commits a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083.
- (7) This section is subject to the Open Government
 Sunset Review Act of 1995 in accordance with s. 119.15, and
 shall stand repealed on October 2, 2004, unless reviewed and
 saved from repeal through reenactment by the Legislature.

Section 2. Access by the State Child Abuse Death Review Committee or a local committee or a panel or committee assembled by the state committee or a local committee to records that are otherwise confidential increases the potential for reduced morbidity or mortality of children and reduces the potential for poor outcomes for children, thereby improving the overall quality of life for children. The Legislature finds that it is a public necessity that such information remain confidential in the hands of the state committee, a local committee, or a panel or committee assembled by them, and in the hands of a hospital or health care practitioner that obtains such information from those entities. The Legislature further finds that it is a public necessity that records and reports of the State Child Abuse Death Review Committee or a local committee or a panel or committee assembled by the state committee or a local committee, and portions of meetings thereof, which relate solely to child fatalities and where specific persons or

2 public records and public meeting requirements. Otherwise, 3 sensitive, personal information concerning children would be 4 disclosed and open communication and coordination among the 5 parties involved in the child fatality reviews would be 6 hampered. Accordingly, the Legislature finds that the harm to 7 the public that would result from the release of such information substantially outweighs any minimal public benefit 8 9 derived therefrom. Section 3.
