17	Section 4. Section 316.2126, Florida Statutes, is		
18	amended to read:		
19	316.2126 Use of golf carts <u>and utility vehicles</u> by		
20	certain municipalities.--In addition to the powers granted by		
21	ss. 316.212 and 316.2125, municipalities older than 400 years		
22	old are hereby authorized to utilize golf carts <u>and utility</u>		
23	<u>vehicles</u> , as defined in s. 320.01, upon any state, county, or		
24	municipal roads located within the corporate limits of such		
25	municipalities, subject to the following conditions:		
26	(1) Golf carts <u>and utility vehicles must comply with</u>		
27	<u>the operational and safety requirements</u> operated beyond the		
28	authority granted in ss. 316.212 and 316.2125 <u>and shall</u> may		
29	only be operated by municipal employees for municipal		
30	purposes, including, but not limited to, police patrol,		
31	traffic enforcement, and inspection of public facilities.

1 (2) In addition to the safety equipment required in s.
2 316.212(6), such golf carts and utility vehicles must be
3 equipped with sufficient lighting and turn signal equipment.

4 (3) ~~The~~ Golf carts and utility vehicles may only be
5 operated on state roads that have a posted speed limit of 30
6 miles per hour or less.

7 Section 5. Section 320.105, Florida Statutes, is
8 amended to read:

9 320.105 Golf carts and utility vehicles;
10 exemption.--Golf carts and utility vehicles, as defined in s.
11 320.01, when operated in accordance with s. 316.212 or s.
12 316.2126, are exempt from provisions of this chapter which
13 require the registration of vehicles or the display of license
14 plates.

15 Section 6. Paragraph (c) of subsection (4) of section
16 325.203, Florida Statutes, is amended to read:

17 325.203 Motor vehicles subject to annual inspection;
