# I. **SUMMARY**:

The bill directs the Department of Transportation (DOT) to display an appropriate marker or plaque at each interstate rest area to recognize members of the United States Armed Forces who are missing in action and unaccounted for. DOT will cooperate with the Department of Veterans' Affairs (FDVA) in implementing these displays.

The bill will have a fiscal impact on DOT that is estimated at a minimum of \$12,000 and a maximum of \$240,000. See "FISCAL COMMENTS" section for details.

The Committee on Transportation adopted one amendment which is traveling with the bill. As indicated in the "AMENDMENTS OR COMMITTEE SUBSTITUTE CHANGES" section the amendment requires The Department of Transportation to fly the POW/MIA flag year round at each rest area along interstate highways in this state.

Currently, there are no markers honoring POW's and MIA's at the 72 rest areas and 8 turnpike service centers along Interstate Highways in Florida. The Department of Transportation in cooperation with the Department of Veterans' Affairs is installing flag poles at all rest areas in order to fly the POW/MIA flag. This process should be completed by 4/10/00.

# C. EFFECT OF PROPOSED CHANGES:

The bill directs the Department of Transportation to display an appropriate marker or plaque at each interstate rest area to recognize members of the United States Armed Forces who are missing in action and unaccounted for. The Department of Transportation will cooperate with the Department of Veterans' Affairs in implementing these displays.

## D. SECTION-BY-SECTION ANALYSIS:

Section 1: Requires the Department of Transportation, in cooperation with the Department of Veterans' Affairs to display an appropriate marker or plague at each rest area along interstate highways in this state recognizing the sacrifices of those servicemen and servicewomen still unaccounted for and acknowledging the sacrifices of their families.

## D. FISCAL COMMENTS:

The bill will have a fiscal impact on DOT that is indeterminate. If signs are used, the cost is approximately \$150 per sign. However, plaques could cost from approximately \$1500 to \$3000. There are currently 72 rest areas and 8 turnpike service centers to be designated. The estimated cost per sign assumes that standard DOT highway sign material will be used for the markers. Therefore, the fiscal impact on DOT is estimated at a minimum of \$12,000 if markers are used, however if granite or bronze plaques are installed the impact could be up to \$240,000.
