I. SUMMARY:

Article III, Section 19(f) of the State Constitution terminates most trust funds four years after their effective date. Prior to such termination, the Legislature reviews trust funds to re-create, terminate, or determine them exempt from automatic termination in accordance with provisions of Article III, Section 19(f) of the State Constitution. This bill includes trust funds that are administered by the Agency for Health Care Administration, the Department of Children and Family Services, and the Department of Veterans' Affairs. This bill terminates three trust funds that have been identified as no longer necessary and renames one trust fund that was recreated in a separate bill.

This bill also renames one trust fund within the Department of Children and Family Services.
