I. SUMMARY:

HB 1155 creates the Off-Highway Vehicle Revolving Trust Fund, which will be funded primarily by fees paid to the Department of Highway Safety and Motor Vehicles for the titling and registration of off-highway vehicles used on public lands. The Florida Off-Highway Vehicle Safety Recreation Act, which provides for the titling and registration of off-highway vehicles used on public land, is created in HB 777.

At the end of any fiscal year, any balance remaining in the trust fund shall be available for carrying out the fund's purpose. Unless terminated sooner, the trust fund will terminate on July 1, 2004. Prior to its termination, the fund shall be reviewed as provided in s. 215.3206(1) and (2), F.S. The bill takes effect on July 1, 2000, and must be enacted by a three-fifths vote of the membership of each house.

Because the purpose of HB 1155 is to simply create the trust fund, the bill has no fiscal impact on state or local governments.

B. PRESENT SITUATION:

Pursuant to Article III, Section 19(f), Florida Constitution, no trust fund of the State of Florida or any public body may be created by law without a three-fifths vote of the membership of each house of the legislature. Additionally, the bill creating the trust fund must be separate from any related substantive bill. HB 1155 is tied to HB 777 relating to off-highway vehicles.

C. EFFECT OF PROPOSED CHANGES:

This bill creates the Off-Highway Vehicle Revolving Trust Fund. The bill is tied to adoption of HB 777 providing for the titling and registration of all off-road vehicles used on public lands. The trust fund is a repository and distribution point for funds specified in HB 777.
