I. <u>SUMMARY</u>:

This legislation re-creates the Legislative Lobbyist Registration Trust Fund without modification, effective November 4, 2000. The Legislative Lobbyist Registration Trust Fund, FLAIR #11-2-442, is administered by the legislative branch. This fund was last re-created effective November 4, 1996, by Chapter 96-87, Laws of Florida.

The House substituted CS/SB 600 for HB 1207 prior to final passage on March 15, 2000.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 11.045, F.S., creates the trust fund, provides sources of revenue for the fund, and defines the uses of the fund. Section 11.047, F.S., provides sources of revenue for the fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund is used for the purpose of funding any office established for the administration of the registration of lobbyists lobbying the Legislature, including the payment of salaries and other expenses.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are fees, fines, and forfeited benefits collected from lobbyists. According to Comptroller data, receipts to this fund for FY 1998-99 were \$197,950.
