I. SUMMARY:

This legislation re-creates the Florida Endowment for Vocational Rehabilitation Fund without modification, effective November 4, 2000. The Florida Endowment for Vocational Rehabilitation Fund is administered by the State Board of Administration. This fund was last recreated effective November 4, 1996, by Chapter 96-143.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 413.615, F.S., creates the trust fund, provides revenue sources for the fund, and defines the use of the fund.

Section 318.21, F.S., provides a revenue source for the fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund provides various programs related to the provision of services to disabled persons.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are legislative appropriations, a portion of civil penalties received from county courts, and various bequests, gifts, grants and donations.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
