I. SUMMARY:

This legislation re-creates the Resident Protection Trust Fund without modification, effective November 4, 2000. The Resident Protection Trust Fund, FLAIR #68-2-522, is administered by the Agency for Health Care Administration. This fund was last re-created effective November 4, 1996, by Chapter 96-133, Laws of Florida.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 400.063, F.S., creates the trust fund, provides sources of revenue for the fund, and defines the uses of the fund.

Sections 393.0673, 400.062, 400.121, and 400.162, F.S., provide sources of revenue for the fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund tracks receipts and expenditures related to the alternate placement, care, and treatment of residents of certain licensed facilities when it is determines by the Agency for Health Care Administration that existing conditions or practices constitute an immediate danger to the health, safety, or security of the residents.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are fines paid by nursing home facility licensees, resident protection fees, and trust funds of deceased residents. According to Comptroller data, receipts to this fund for FY 1998-99 were \$1,751,259.12
