I. SUMMARY:

This legislation re-creates the Child Care and Development Block Grant Trust Fund without modification, effective November 4, 2000. The Child Care and Development Block Grant Trust Fund, FLAIR # 60-2-098, is administered by the Department of Children and Family Services. This fund was last re-created effective November 4, 1996, by Chapter 96-103, Laws of Florida.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 402.3051, F.S., defines the uses of the fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund tracks receipts and expenditures of the federal Child Care Development Fund Grant and transfers from TANF to support services and activities in subsidized child care.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are federal block grant funds. According to Comptroller data, receipts to this fund for FY 1998-99 were \$213,438,486.29.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
