A bill to be entitled 1 An act relating to trust funds; re-creating the 2 3 Federal Grants Trust Fund within the Department of Health without modification; carrying 4 5 forward current balances and continuing current sources and uses thereof; amending s. 20.435, 6 7 F.S.; abrogating future termination of the 8 trust fund; providing an effective date. 9 10 WHEREAS, the Legislature wishes to extend the life of 11 the Federal Grants Trust Fund within the Department of Health, which is otherwise scheduled to be terminated pursuant to 12 13 constitutional mandate, and WHEREAS, the Legislature has reviewed the trust fund 14 before its scheduled termination date and has found that it 15 16 continues to meet an important public purpose, and 17 WHEREAS, the Legislature has found that existing public 18 policy concerning the trust fund sets adequate parameters for 19 its use, NOW, THEREFORE, 20 21 Be It Enacted by the Legislature of the State of Florida: 22 23 Section 1. (1) The Federal Grants Trust Fund within the Department of Health, FLAIR number 64-2-261, which is to 24 be terminated pursuant to Section 19(f), Article III of the 25 26 State Constitution on July 1, 2001, is re-created. All current balances of the trust fund are carried 27 28 forward, and all current sources and uses of the trust fund 29 are continued. Section 2. Paragraph (b) of subsection (1) of section 30 20.435, Florida Statutes, is amended to read:

1	20.435 Department of Health; trust funds
2	(1) The following trust funds are hereby created, to
3	be administered by the Department of Health:
4	(b) Federal Grants Trust Fund.
5	1. Funds to be credited to the trust fund shall
6	consist of grants and funding from the Federal Government and
7	funds from the Medicaid program. Funds shall be used for the
8	purposes of providing health and support services to
9	department clients, supporting regulatory activities of the
LO	department, and funding disease surveillance and for other
L1	such purposes as may be appropriate and shall be expended only
L2	pursuant to legislative appropriation or an approved amendment
L3	to the department's operating budget pursuant to the
L4	provisions of chapter 216.
L5	2. Notwithstanding the provisions of s. 216.301 and
L6	pursuant to s. 216.351, any balance in the trust fund at the
L7	end of any fiscal year shall remain in the trust fund at the
L8	end of the year and shall be available for carrying out the
L9	purposes of the trust fund.
20	3. The trust fund shall, unless terminated sooner, be
21	terminated on July 1, 2001.
22	Section 3. This act shall take effect November 4,
23	2000.
