(1) The Social Services Block Grant Trust 24 Fund within the Department of Health, FLAIR number 64-2-639, 25 26 which is to be terminated pursuant to Section 19(f), Article III of the State Constitution on July 1, 2001, is re-created. 27 28 (2) All current balances of the trust fund are carried

forward, and all current sources and uses of the trust fund

are continued.

Section 2. Paragraph (f) of subsection (1) of section 1 2 20.435, Florida Statutes, is amended to read: 3 20.435 Department of Health; trust funds.--4 (1) The following trust funds are hereby created, to 5 be administered by the Department of Health: 6 (f) Social Services Block Grant Trust Fund. 7 1. Funds to be credited to the trust fund shall 8 consist of federal social services block grant funds. Funds 9 shall be used for the purpose of providing health care and support services to department clients and for other such 10 11 purposes as may be appropriate and shall be expended only pursuant to legislative appropriation or an approved amendment 12 13 to the department's operating budget pursuant to the provisions of chapter 216. 14 15 2. Notwithstanding the provisions of s. 216.301 and 16 pursuant to s. 216.351, any balance in the trust fund at the end of any fiscal year shall remain in the trust fund at the 17 18 end of the year and shall be available for carrying out the purposes of the trust fund. 19 20 The trust fund shall, unless terminated sooner, 21 terminated on July 1, 2001. 22 Section 3.
