**I. SUMMARY:**

This legislation re-creates the Florida Korean Veterans Memorial Matching Trust Fund without modification, effective November 4, 2000. The Florida Korean Veterans Memorial Matching Trust Fund, FLAIR #50-2-107, is administered by the Department of Veterans' Affairs. This fund was created, effective July 1, 1996, by Chapter 96-334, Laws of Florida.

**II. SUBSTANTIVE ANALYSIS:**

**A. PRESENT SITUATION:**

**2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:**

The fund is used to receive donations for the Korean Veterans Memorial.

**3. MAJOR SOURCES OF REVENUE FOR THE FUND:**

The major sources of revenue for the fund are private contributions and matching state funds. According to Comptroller data, receipts to this fund for FY 1998-99 were \$26,242.50.
