**Amendment to Amendment (960907) (with title amendment)**

On page 71, between lines 5 and 6,

insert:

Section 46. Subsection (1) of section 350.031, Florida Statutes, is amended to read:

350.031 Florida Public Service Commission Nominating Council.--

(1) There is created a Florida Public Service Commission Nominating Council consisting of nine members. At least one member of the council must be 60 years of age or older. Three members, including one member of the House of Representatives, shall be appointed by and serve at the pleasure of the Speaker of the House of Representatives; three members, including one member of the Senate, shall be appointed by and serve at the pleasure of the President of the Senate; and three members shall be selected and appointed by a majority vote of the other six members of the council. All terms shall be for 4 years except those members of the House

1 and Senate, who shall serve 2-year terms concurrent with the  
 2 2-year elected terms of House members. Vacancies on the  
 3 council shall be filled for the unexpired portion of the term  
 4 in the same manner as original appointments to the council. A  
 5 member may not be reappointed to the council, except for a  
 6 member of the House of Representatives or the Senate who may  
 7 be appointed to two 2-year terms or a person who is appointed  
 8 to fill the remaining portion of an unexpired term.

9 Section 47. This act applies to any person who is a  
 10 member of the Florida Public Service Commission Nominating  
 11 Council on the effective date of this act.
