I. SUMMARY:

This legislation re-creates the Energy Consumption Trust Fund without modification, effective November 4, 2000. The Energy Consumption Trust Fund, FLAIR #52-2-174, is administered by the Department of Community Affairs. This fund was last re-created effective November 4, 1996, by Chapter 96-418, Laws of Florida.

The House substituted SB 482 for HB 1337 prior to final passage on March 15, 2000.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 420.36, F.S., creates the trust fund, provides sources of revenue for the fund, and defines the uses of the fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund is used to fund the Low-income Emergency Home Repair Program.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are federal funds. According to Comptroller data, receipts to this fund for FY 1998-99 were \$29,766,289.58.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
