I. SUMMARY:

This legislation re-creates the Administrative Trust Fund without modification, effective November 4, 2000. The Administrative Trust Fund, FLAIR #54-2-021, is administered by the Department of Labor and Employment Security. This fund was last re-created effective November 4, 1996, by Chapter 96-43, Laws of Florida.

The House substituted SB 568 for HB 1359 prior to final passage on March 15, 2000.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund is used to provide administrative support for the Department of Labor and Employment Security.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are indirect cost charges to divisions within the department. According to Comptroller data, receipts to this fund for FY 1998-99 were \$21,344,444.13.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
