I. SUMMARY:

This legislation re-creates the Revolving Trust Fund without modification, effective November 4, 2000. The Revolving Trust Fund, FLAIR #54-2-600, is administered by the Department of Labor and Employment Security. This fund was last re-created effective November 4, 1996, by Chapter 96-38, Laws of Florida.

The House substituted SB 580 for HB 1371 prior to final passage on March 15, 2000.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

No reference in statutes.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund is used as a proprietary fund for agency stockroom, print shop, mail services, etc.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are user fees charged to divisions within the Department of Labor and Employment Security. According to Comptroller data, receipts to this fund for FY 1998-99 were \$4,636,510.31.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.

III. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT:

This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector. It simply re-creates, without modification, an existing state trust fund and continues the current use of the fund.
