I. SUMMARY:

This legislation re-creates the Working Capital Trust Fund without modification, effective November 4, 2000. The Working Capital Trust Fund, FLAIR #54-2-792, is administered by the Department of Labor and Employment Security. This fund was last re-created effective November 4, 1996, by Chapter 96-40, Laws of Florida.

The House substituted SB 590 for HB 1381 prior to final passage on March 15, 2000.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 216.272, F.S., creates all Working Capital Trust Funds, provides revenue sources for the fund, and defines the uses of the fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund is used to support the operation of the Information Management Center of the Department of Labor and Employment Security.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are user fees charged to divisions within the Department of Labor and Employment Security. According to Comptroller data, receipts to this fund for FY 1998-99 were \$19,337,045.44.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
