This bill extends the date of expiration for the operation of the Barron Water Control District of Glades and Hendry counties from May 7, 2005 to September 30, 2020.

According to the Economic Impact Statement, this bill contains a positive fiscal impact.

B. PRESENT SITUATION:

The formation of the Barron Water Control District, which includes areas in both Glades and Hendry Counties, was requested through petition of the Circuit Court under ch. 298, F.S. (Case Number 72-197). The Twentieth Judicial Circuit Court for Hendry County granted this petition by court order on May 8, 1975. The petition includes a provision that the incorporation status of the District remain in existence for thirty years. The District is set to expire on May 7, 2005. Due to the present expiration date, the debt must be paid off entirely in 5 years.

Chapter 84-436, L.O.F., addresses the single issue of the modification of a quorum for the District.

C. EFFECT OF PROPOSED CHANGES:

Extending the expiration date allows the District to likewise extend its assessments, so that the actual annual repayments are lower. According to the Economic Impact Statement, the District will also continue to provide a positive contribution to both the private and open agricultural market.

D. SECTION-BY-SECTION ANALYSIS:

Section 1 -- Provides that extending the incorporation status of the Barron Water Control District of Glades and Hendry Counties results in the following benefits: the District can raise funds, fulfill the terms of its water management plan, pay for completed projects, pay off bonds, and build new works; Extends date of operation of Barron Water Control District, from its scheduled expiration date of May 7, 2005, to a later expiration date of midnight, September 30, 2020.

Section 2 -- Provides for an effective date upon becoming a law.
