A new Fine Arts Building at Florida 12 Atlantic University's John D. MacArthur Campus in Jupiter is 13 hereby designated as the "Hibel Fine Arts Building" in 14 recognition of Edna Hibel. 15 Section 5. New classroom and office space for the 16 17 College of Business at Florida Atlantic University's Boca Raton Campus is hereby designated as the "Carl DeSantis 18 19 Pavilion." 20 Section 6. The new presidential residence at Florida Atlantic University's Boca Raton Campus is hereby designated 21 as the "Eleanor R. Baldwin House." 22 Section 7. Academic Building #2, which houses the 23 24 Colleges of Arts & Sciences and Business at Florida Gulf Coast 25 University, is hereby designated as "Charles B. Reed Hall" in recognition of the former chancellor of the State University 26 27 System of Florida. 28 Section 8. The Student Services Building at Florida 29 Gulf Coast University is hereby designated as the "Roy E. 30 McTarnaghan Hall" in recognition of the founding president of Florida Gulf Coast University. 31
