photographs, and places of employment of the spouses and 1 2 children of such personnel; and the names and locations of 3 schools and day care facilities attended by the children of such personnel are exempt from the provisions of subsection 4 5 (1). The home addresses, telephone numbers, and photographs of firefighters certified in compliance with s. 633.35; the home 6 7 addresses, telephone numbers, photographs, and places of 8 employment of the spouses and children of such firefighters; 9 and the names and locations of schools and day care facilities attended by the children of such firefighters are exempt from 10 11 subsection (1). The home addresses and telephone numbers of 12 justices of the Supreme Court, district court of appeal 13 judges, circuit court judges, and county court judges; the 14 home addresses, telephone numbers, and places of employment of the spouses and children of justices and judges; and the names 15 16 and locations of schools and day care facilities attended by the children of justices and judges are exempt from the 17 provisions of subsection (1). county and municipal code inspectors and code enforcement officers are confidential and exempt from the provisions of subsection (1) and s. 24(a), Art. I of the State Constitution.

2. The home addresses, telephone numbers, social security numbers, and photographs of current or former human resource, labor relations, or employee relations directors, assistant directors, managers, or assistant managers of any local government agency whose duties include hiring and firing employees, labor contract negotiation, administration, or other personnel-related duties; the names, home addresses, telephone numbers, social security numbers, photographs, and places of employment of the spouses and children of such personnel; and the names and locations of schools and day care facilities attended by the children of such personnel are exempt from subsection (1) and s. 24(a), Art. I of the State Constitution. This subparagraph is subject to the Open Government Sunset Review Act of 1995 in accordance with s. 119.15, and shall stand repealed on October 2, 2005, unless reviewed and saved from repeal through reenactment by the Legislature.

3.2. An agency that is the custodian of the personal information specified in subparagraph 1. or subparagraph 2. and that is not the employer of the officer, employee, justice, judge, or other person specified in subparagraph 1. or subparagraph 2. shall maintain the confidentiality of the personal information only if the officer, employee, justice, judge, other person, or employing agency of the designated employee submits a written request for confidentiality to the custodial agency.

Section 2. <u>The Legislature finds that the exemption</u> from public records requirements provided by this act for
