The Public Counsel shall have such 19 20 powers as are necessary to carry out the duties of his or her 21 office, including, but not limited to, the following specific 22 powers: 23 (1) To recommend to the commission, by petition, the commencement of any proceeding or action or to appear, in the 24 25 name of the state or its citizens, in any proceeding or action before the commission and urge therein any position which he 26 27 or she deems to be in the public interest, whether consistent 28 or inconsistent with positions previously adopted by the commission, and utilize therein all forms of discovery 29 30 available to attorneys in civil actions generally, subject to 31

At the conclusion of the recovery period, 27 28 the rate of the public utility shall be reduced immediately by 29 the amount of rate case expense previously included in rates. 30 Section 3. This act shall take effect upon becoming a 31 law.
