It is the intent of the Legislature to 1 2 provide a single, comprehensive special act charter for the 3 Alva Fire Protection and Rescue Service District which 4 includes all current legislative authority granted to the district by general law and by its several legislative 5 6 enactments, as said laws may be amended from time to time, and 7 any additional authority granted by this act. Section 2. Codification.--Chapters 76-413, 81-414, 8 9 83-449, 83-454, 87-447, 88-545, and 90-388, Laws of Florida, relating to the Alva Fire Protection and Rescue Service 10 District, are hereby codified, reenacted, and amended as 11 12 provided herein. Section 3. The Alva Fire Protection and Rescue Service 13 14 District, an independent special district, is re-created and 15 the charter for such district is re-created and reenacted to 16 read: 17 Section 1. Creation. -- There is hereby made, created and established the Alva Fire Protection and Rescue Service 18 District, an independent special district, hereinafter 19 20 referred to as the district, through the codification and reenactment of the district's several legislative enactments, 21 which shall include the following described lands: 22 23 24 In Township 43 South, Range 27 East, all of Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 25 26 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 32, 33, 34 and 35 and that 27 portion of Sections 30, 31 and 36 that does not 28 29 lie in the Lehigh Acres Fire Control and Rescue District, and in Township 43 South, Range 26 30 East all of Sections 1, 2, 3, 10, 11, 12, 13, 31 2

The district shall have 24 and the board may exercise those general and special powers 25 prescribed by chapter 191, Florida Statutes, chapter 97-340, 26 27 Laws of Florida, or any other applicable general law or 28 special law, as said laws may be amended from time to time. 29 Section 4. Emergency medical and rescue response 30 services.--The district is authorized to establish and 31 maintain emergency medical and rescue response services and 3

acquire and maintain rescue, medical, transport and other 1 emergency equipment as prescribed by general law and special 2 3 law, as said laws may be amended from time to time. Section 5. Policies, rules and regulations and fire 4 code. -- The board is authorized to make and adopt policies, 5 6 rules, regulations and a fire code for the prevention of 7 fires, for fire control, and for the provision of rescue 8 services within the district. Such policies, rules, 9 regulations and fire code shall be adopted in accordance with applicable general law and special law, as said laws may be 10 amended from time to time. 11 12 Section 6. Taxes; non-ad valorem assessments; impact fees; user charges.--The district board shall fix and cause to 13 14 be levied on all property of the district, a millage 15 sufficient to meet the requirements of the adopted budget; provided, however, two (2) mills is the maximum that can be 16 17 levied in any one (1) year, except as provided in chapter 191, Florida Statutes, chapter 97-340, Laws of Florida, or any 18 19 other applicable general law or special law, as said laws may 20 be amended from time to time. In addition, the district shall have such authority to levy non-ad valorem assessments and 21 charge impact fees and user charges as prescribed in chapter 22 23 191, Florida Statutes, chapter 97-340, Laws of Florida, and any other applicable general law or special law as said laws 24 may be amended from time to time. 25 26 Section 7. Assessment and collection of taxes, assessments, impact fees and user charges.--Taxes, 27 assessments, impact fees and user charges herein provided for 28 29 shall be assessed and collected in the manner prescribed by applicable general law or special law, as said laws may be 30 31 amended from time to time. 4

Section 4. This act shall be construed as a remedial act and shall be liberally construed to promote the purpose for which it is intended which is a codification, reenactment, and repeal of the several legislative enactments of the district. Section 5. Chapters 76-413, 81-414, 83-449, 83-454, 87-447, 88-545 and 90-388, Laws of Florida, are repealed. Section 6. In the event any section or provision of this act is determined to be invalid or unenforceable, such determination shall not affect the validity of or enforceability of each other section and provision of this act. Section 7. In the event of a conflict of the provisions of this act with the provisions of any other act the provisions of this act shall control to the extent of such conflict. Section 8.
