Section 27. Subsection (5) of section 320.27, Florida Statutes, is amended to read:

320.27 Motor vehicle dealers.--

(5) SUPPLEMENTAL LICENSE.--Any person licensed

hereunder shall obtain a supplemental license for each permanent additional place or places of business not contiguous to the premises for which the original license is issued, on a form to be furnished by the department, and upon payment of a fee of \$50 for each such additional location.

Upon making renewal applications for such supplemental licenses, such applicant shall pay \$50 for each additional location. A supplemental license authorizing off-premises sales shall be issued, at no charge to the dealer, for a period not to exceed 10 consecutive calendar days. To obtain such a temporary supplemental license for off-premises sales,

1 the applicant must be a licensed dealer; must notify the
 2 applicable local department office of the specific dates and
 3 location for which such license is requested, display a sign
 4 at the licensed location clearly identifying the dealer, and
 5 provide staff to work at the temporary location for the
 6 duration of the off-premises sale; must meet any local
 7 government permitting requirements; and must have permission
 8 of the property owner to sell at that location. In the case of
 9 an off-premises sale by a motor vehicle dealer licensed under
 10 s. 320.27(1)(c)1. for the sale of new motor vehicles, the
 11 applicant must also include documentation notifying the
 12 applicable licensee licensed under s. 320.61 of the intent to
 13 engage in an off-premises sale 5 working days prior to the
 14 date of the off-premises sale. The licensee shall either
 15 approve or disapprove of the off-premises sale with 2 working
 16 days after receiving notice; otherwise, it will be deemed
 17 approved. This section does not apply to a nonselling motor
 18 vehicle show or public display of new motor vehicles.
