18 disorders, appointed by the Florida Medical Association.
19 (l) A member of a Florida chapter of the American
20 Association of Retired Persons, appointed by the association.
21 (m) An individual who has experience with periodic
22 review of nursing homes and other long-term care facilities,
23 appointed by the Attorney General.
24 (n) A representative of the Florida Health Care
25 Association, appointed by the association.
26 (o) A local volunteer long-term care ombudsman with at
27 least 2 years of experience in assisting residents of nursing
28 homes and assisted living facilities, appointed by the State
29 Long-term Care Ombudsman.
30 (p) Two consumer representatives, one appointed by the
