Notwithstanding any provisions in this section to the contrary, the one-stop 31 1

delivery system shall be the primary method for delivering 1 services under this section, consistent with Pub. L. No. 2 3 105-220 and chapter 445.It shall be the duty of the agency 4 division to cooperate with any official or agency of the 5 United States having power or duties under the provisions of the Act of Congress, as amended, and to do and perform all 6 7 things necessary to secure to this state the benefits of said Act of Congress, as amended, in the promotion and maintenance 8 9 of a system of public employment offices. The provisions of 10 the said Act of Congress, as amended, are hereby accepted by this state, in conformity with s. 4 of that act, and this 11 12 state will observe and comply with the requirements thereof. The Agency for Workforce Innovation Division of Jobs and 13 14 Benefits of the Department of Labor and Employment Security is 15 hereby designated and constituted the agency of this state for 16 the purpose of that act. The agency division is authorized 17 and directed to appoint sufficient employees to carry out the purposes of this section. The agency division may cooperate 18 with or enter into agreements with the Railroad Retirement 19 Board with respect to the establishment, maintenance, and use 20 21 of free employment service facilities.

(2) FINANCING. -- All moneys received by this state 22 under the said Act of Congress, as amended, shall be paid into 23 24 the Employment Security Administration Trust Fund, and such 25 moneys are hereby made available to the agency division to be 26 expended as provided by this chapter and by said Act of 27 Congress. For the purpose of establishing and maintaining free public employment offices, the agency division is 28 authorized to enter into agreements with the Railroad 29 30 Retirement Board or any other agency of the United States 31 charged with the administration of an unemployment
