On page 76, between lines 7 and 8, of the bill of the bill

insert:

(1) The Correctional Privatization Commission created under chapter 957, Florida Statutes, in consultation with the Department of Children and Family Services, shall develop and issue a request for proposal for the financing, design, construction, acquisition, ownership, leasing, and operation of a secure facility of at least 400 beds to house and rehabilitate sexual predators committed under the Jimmy Ryce Act of 1998. The Secretary of the Department of Children and Families shall retain final approval of the request for proposal, the successful bidder, and the contract.

(2) This constitutes specific legislative authorization for the Correctional Privatization Commission to enter into a contract with a provider for the financing, design, construction, acquisition, ownership, leasing, and

1 operation of a secure facility to house and rehabilitate
2 sexual predators to be constructed in DeSoto County, Florida.
3 (3) The selected contractor for the financing, design,
4 construction, acquisition, ownership, leasing and operation of
5 the secure facility is authorized to enter into a lease
6 arrangement or other private financing, or to sponsor the
7 issuance of tax exempt bonds, certificates of participation,
8 or other public or private means to finance the facility. The
9 state is authorized to enter into all such agreements as are
10 necessary, including lease alternatives, to bring the facility
11 to an operational state and to commence leasing of the
12 facility.

13 (4) Upon completion of the sexual predator secure
14 treatment facility in DeSoto County, the Martin Sexually
15 Violent Predator Treatment and Retaining Program shall be
16 phased out, to be terminated within 1 year of completion of
17 the facility.
