University mission. -- The mission of the 7 baccalaureate and master's degree oriented universities is to provide high-quality undergraduate education at an affordable 8 price, and to promote regional and statewide economic 9 10 development. Initially, course offerings will be limited to core programs in the liberal arts and sciences, technology, 11 12 and a limited number of professional programs, including business and education. The role of these universities is to 13 complement, not compete with, community colleges and 14 15 institutions in the State University System. This role will be accomplished by encouraging interinstitutional cooperation and 16 17 by providing upper-division undergraduate opportunities to 18 community college transfer students, particularly students with associate in science degrees transferring into 19 baccalaureate programs. An additional component of the role of 20 21 New College will be to continue to maintain its liberal arts honors program of national distinction and to continue to be 22 the honors college of the State of Florida. The emphasis at 23 24 these new universities will be on teaching, not research. Instruction will be primarily at the baccalaureate degree 25 level with a limited number of master's degree level courses 26 27 and programs. A baccalaureate and master's degree oriented 28 university shall contract with a local community college to 29 provide lower-division instruction. This primary mission does 30 not preclude one of these universities from entering into a joint-use agreement with any institution in the State 31

University System to offer master's and doctoral degree 1 programs on the baccalaureate and master's degree oriented 2 3 university campus. 4 Section 10. Operational plan. -- The baccalaureate and 5 master's degree oriented universities shall begin admitting 6 students for classes beginning with the fall term of the 7 2002-2003 academic year. The Postsecondary Education Planning Commission shall develop an operational plan for inaugurating 8 the universities and present its recommendations to the 9 10 President of the Senate, the Speaker of the House of 11 Representatives, and the Governor by January 1, 2001. 12 Section 11. University boards of trustees .--13 (1) Each baccalaureate and master's degree oriented university must be governed by a board of trustees comprised 14 15 of nine members who must be residents of the county in which the university is located. (6) The board of trustees shall have the power to take 10 action without the recommendation of the president and may 11 12 require the president to deliver to the board all data and 13 information required by the board in the performance of its 14 duties. 15 Section 12. University board of trustees to constitute 16 a corporation. -- Each baccalaureate and master's degree 17 oriented university board of trustees is constituted a body corporate by the name of "The Board of Trustees of 18 19 University at \_\_\_\_ \_\_\_\_\_, Florida." In all suits against the board, service of process shall be made on 20 21 the chair of the board or, in the absence of the chair, on another member of the board. 22 Section 13. University boards of trustees; powers and 23 24 duties.--(1) Each university board of trustees is vested with 25 the responsibility to operate its respective university and 26 27 with the necessary authority for the proper operation and 28 improvement of the university in accordance with the rules of 29 the State Board of Education. 30 (2) Each university board of trustees shall adopt rules, procedures, and policies consistent with law and rules 31 4

The board of trustees 11 may appoint a presidential search committee. 12 (b) Each board of trustees shall have responsibility for the establishment and discontinuance of program and course 13 offerings; the provision of instructional and noninstructional 14 15 community services; the location of classes and services provided; and the dissemination of information concerning the 16 17 programs and services. 18 (c) Each board of trustees shall constitute the contracting agent of the university. A board of trustees may, 19 20 when acting as a body, make contracts, sue, and be sued in the 21 name of the board of trustees. (d) Whenever the Department of Education finds it 22 necessary for the welfare and convenience of any university to 23 24 acquire private property for the use of the university, and the property cannot be acquired by agreement satisfactory to 25 the board of trustees of the university and the parties 26 27 interested in or the owners of the private property, the university board of trustees may exercise the right of eminent 28 domain after receiving approval from the State Board of 29 30 Education and may then proceed to condemn the property in the manner provided by chapters 73 and 74, Florida Statutes. 31
