17	Section 2. Effective upon this act becoming a law,		
18	paragraph (f) of subsection (6) of section 212.20, Florida		
19	Statutes, is amended to read:

22	adjudicated unconstitutionally collected.--		
23	(6) Distribution of all proceeds under this chapter		
24	shall be as follows:		
25	(f) The proceeds of all other taxes and fees imposed		
26	pursuant to this chapter shall be distributed as follows:		
27	1. In any fiscal year, the greater of \$500 million,		
28	minus an amount equal to 4.6 percent of the proceeds of the		
29	taxes collected pursuant to chapter 201, or 5 percent of all		
30	other taxes and fees imposed pursuant to this chapter shall be		
31	deposited in monthly installments into the General Revenue

2 2. Two-tenths of one percent shall be transferred to
3 the Solid Waste Management Trust Fund.

4 3. After the distribution under subparagraphs 1. and
5 2., 9.653 percent of the amount remitted by a sales tax dealer
6 located within a participating county pursuant to s. 218.61
7 shall be transferred into the Local Government Half-cent Sales
8 Tax Clearing Trust Fund.

9 4. After the distribution under subparagraphs 1., 2.,
10 and 3., 0.054 percent shall be transferred to the Local
11 Government Half-cent Sales Tax Clearing Trust Fund and
12 distributed pursuant to s. 218.65.

13 5. Of the remaining proceeds:

14 a. Beginning July 1, 1992, \$166,667 shall be
15 distributed monthly by the department to each applicant that
16 has been certified as a "facility for a new professional
17 sports franchise" or a "facility for a retained professional
18 sports franchise" pursuant to s. 288.1162 and \$41,667 shall be
19 distributed monthly by the department to each applicant that
20 has been certified as a "new spring training franchise
21 facility" pursuant to s. 288.1162. Distributions shall begin
22 60 days following such certification and shall continue for 30
23 years. Nothing contained herein shall be construed to allow an
24 applicant certified pursuant to s. 288.1162 to receive more in
25 distributions than actually expended by the applicant for the
26 public purposes provided for in s. 288.1162(7). However, a
27 certified applicant shall receive distributions up to the
28 maximum amount allowable and undistributed under this section
29 for additional renovations and improvements to the facility
30 for the franchise without additional certification.

31 b. Beginning 30 days after notice by the Office of

1 Tourism, Trade, and Economic Development to the Department of
2 Revenue that an applicant has been certified as the
3 professional golf hall of fame pursuant to s. 288.1168 and is
4 open to the public, \$166,667 shall be distributed monthly, for
5 up to 300 months, to the applicant.

6 c. Beginning 30 days after notice by the Office of
7 Tourism, Trade, and Economic Development ~~Department of~~
8 ~~Commerce~~ to the Department of Revenue that the applicant has
9 been certified as the International Game Fish Association
10 World Center facility pursuant to s. 288.1169, and the
11 facility is open to the public, \$83,333 shall be distributed
12 monthly, for up to 168 ~~180~~ months, to the applicant. This
13 distribution is subject to reduction pursuant to s. 288.1169.
14 A lump-sum payment of \$999,996 shall be made after
15 certification and before July 1, 2000.

16 6. All other proceeds shall remain with the General
17 Revenue Fund.

18 Section 3. This act shall take effect upon becoming a
19 law, except that section 1 of this act shall take effect
20 January 1, 2001.
