7 (b) Provide recommendations expanding or refining the  
8 goals identified in s. 259.105(4).

9 (c) Identify specific performance measures that may be  
10 used to analyze progress towards the goals established.

11 ~~(c) Provide recommendations for the development and~~  
12 ~~identification of performance measures to be used for~~  
13 ~~analyzing the progress made towards the goals established~~  
14 ~~pursuant to s. 259.105(4).~~

15 ~~(d) Provide recommendations for the process by which~~  
16 ~~projects are to be submitted, reviewed, and approved by the~~  
17 ~~Acquisition and Restoration Council. The advisory council is~~  
18 ~~to specifically examine ways to streamline the process created~~  
19 ~~by the Florida Forever Act.~~
