17	Section 7. Present subsection (5) of section 561.32,		
18	Florida Statutes, is renumbered as subsection (6) and amended,

20	561.32 Transfer of licenses; change of officers or

22	<u>(5)(a) Notwithstanding any other provision of law,</u>		
23	<u>except as provided in paragraph (b), any license issued after</u>		
24	<u>October 1, 2000, under s. 561.20(1) shall not be transferable</u>		
25	<u>in any manner either directly or indirectly, including by any</u>		
26	<u>change in stock, partnership shares, or other form of</u>		
27	<u>ownership of any entity holding the license, except by probate</u>		
28	<u>or guardianship proceedings. Any attempted assignment, sale,</u>		
29	<u>or transfer of interest in such license either directly or</u>		
30	<u>indirectly in violation of this provision is declared void,</u>		
31	<u>and the license shall be deemed abandoned and shall revert to</u>

8 However, if the county is only authorized for the issuance of  
9 a liquor license for package sales only, the transfer fee
