(b) Notwithstanding any other provision of law to the contrary beginning with fiscal year 2000-2001 and annually thereafter, the first \$50,000 in general revenue generated from the sale of each of the license plates issued under s. 320.089 which are stamped with the words "National Guard," 'Pearl Harbor Survivor," "Combat-wounded veteran," or "U.S. Reserve" shall be deposited into the Grants and Donations Trust Fund, as described in s. 296.38(2), to be used for the purposes established by law for that trust fund.

Section 2. Paragraph (b) of subsection (19) and paragraph (b) of subsection (31) of section 320.08058, Florida Statutes, are amended to read:

- (19) SEA TURTLE LICENSE PLATES. --
- (b) The annual use fees shall be deposited in the Marine Resources Conservation Trust Fund in the Fish and Wildlife Conservation Commission. The first \$500,000 in annual

revenue shall be used by the Florida Marine Turtle Protection Program to conduct sea turtle protection, research, and recovery programs. Additional license plate revenue, up to an amount not exceeding 30 percent of the total annual revenue, shall be dispersed annually through the marine turtle grants program as provided in s. 370.12(1)(h). The remaining annual use proceeds shall be used by the Florida Marine Turtle

Protection Program for sea turtle conservation activities. The remaining annual use proceeds shall be used by the commission for sea turtle conservation activities, except that up to 30 percent of the remaining annual use fee proceeds shall be annually disbursed through the marine turtle grants program as provided in s. 370.12(1)(h).
