Subsection (3) of section 159.703, Florida 11 12 Statutes, is amended to read: 159.703 Creation of research and development 13 14 authorities.--15 (3) The resolution shall designate not less than five 16 persons who are residents and electors of, or have their 17 principal place of employment in, the county as members of the authority created for said county. Of the members first 18 19 appointed, one shall serve for 1 year, one for 2 years, one for 3 years, and the remainder for 4 years and in each case 20 until his or her successor is appointed and has qualified. 21 22 Thereafter, the board shall appoint for terms of 4 years each a member or members to succeed those whose terms expire, 23 24 except that with respect to an authority that owns, occupies, or maintains a research development park, as defined in s. 25 26 159.27(7), within which is located a substantial capital 27 project that is funded in whole or in part by the state, and is a part of or directly affiliated with the National High 28 29 Magnetic Field Laboratory, the first two such vacancies that occur on or after July 1, 1991, shall not be filled. 30 In addition to the other members, the president of each 31 1

affiliated institution of higher education, or the president's 1 designee, shall be a member of the authority and shall serve 2 3 ex officio; provided, further, that with respect to an 4 authority that owns, occupies, or maintains a research 5 development park, as defined in s. 159.27(7), within which is located a substantial capital project that is funded in whole б 7 or in part by the state, and is a part of or directly affiliated with the National High Magnetic Field Laboratory, 8 9 the Chancellor of the State University System or the Chancellor's designee, the Director of the National High 10 Magnetic Field Laboratory or the director's designee, one 11 12 resident of the county in which the research development park is located appointed by the President of the Senate to serve 13 14 at the pleasure of the President of the Senate, and one resident of the county in which the research development park 15 is located appointed by the Speaker of the House of 16 17 Representatives to serve at the pleasure of the Speaker of the House of Representatives shall be members of the authority and 18 19 shall serve ex officio. Except as to members who serve ex officio, the board shall fill any vacancy for an unexpired 20 term. A member of the authority shall be eligible for 21 reappointment. Any member of the authority may be removed by 22 the board for misfeasance, malfeasance, or willful neglect of 23 duty. Each member of the authority before entering upon his 24 or her duties shall take and subscribe the oath or affirmation 25 26 required by the State Constitution.
