| 14 | (1) There is created the Condominium Study Commission.         |
| 15 | The commission is to consist of 15 members. Five members of    |
| 16 | the commission, at least two of whom are members of the        |
| 17 | Legislature, are to be appointed by the Speaker of the House   |
| 18 | of Representatives; five members, at least two of whom are     |
| 19 | members of the Legislature, are to be appointed by the         |
| 20 | President of the Senate; and five members who are not members  |
| 21 | of the Legislature are to be appointed by the Governor.        |
| 22 | Persons appointed to the commission should represent a         |
| 23 | cross-section of persons interested in condominium issues. In  |
| 24 | addition to the appointed members, the director of the         |

relating to condominiums and may receive recommendations for 1 changes to the condominium law. The commission may consider, 2 without limitation, the continued tension between unit owners 3 and boards of directors, the election process for the board of 4 5 directors, the effectiveness of the Division of Florida Land 6 Sales, Condominiums, and Mobile Homes in responding to 7 complaints from unit owners, the relationship of rights and 8 responsibilities of unit owners and the board, the method of 9 enforcement of condominium liens, and whether the condominium should be able to foreclose condominium liens against 10 individual units. Members of the commission may receive per 11 12 diem and travel expenses pursuant to section 112.061, Florida 13 Statutes, while on official business of the commission. (3) The commission shall report its recommendations 14 and findings to the Governor, the President of the Senate, the 15 16 Speaker of the House of Representatives, and the minority 17 leaders of the Senate and the House of Representatives on or before February 1, 2001, for the 2001 Regular Session of the 18 19 Legislature. 20 Section 2.
