(1) The Medical Quality Assurance Trust 25 Fund within the Department of Health, FLAIR number 64-2-352, 26 which is to be terminated pursuant to Section 19(f), Article 27 III of the State Constitution on July 1, 2001, is re-created. 28 (2) All current balances of the trust fund are carried

1 Section 2. Paragraph (d) of subsection (1) of section 2 20.435, Florida Statutes, is amended to read: 3 20.435 Department of Health; trust funds.--4 (1) The following trust funds are hereby created, to 5 be administered by the Department of Health: 6 (d) Medical Quality Assurance Trust Fund. 7 Funds to be credited to the trust fund shall 8 consist of fees and fines related to the licensing of health 9 care professionals. Funds shall be used for the purpose of 10 providing administrative support for the regulation of health 11 care professionals and for other such purposes as may be appropriate and shall be expended only pursuant to legislative 12 13 appropriation or an approved amendment to the department's operating budget pursuant to the provisions of chapter 216. 14 15 2. Notwithstanding the provisions of s. 216.301 and pursuant to s. 216.351, any balance in the trust fund at the 16 17 end of any fiscal year shall remain in the trust fund at the end of the year and shall be available for carrying out the 18 19 purposes of the trust fund. 20 3.
