Paragraph (f) of subsection (1) of section 1 2 20.435, Florida Statutes, is amended to read: 3 20.435 Department of Health; trust funds.--4 (1) The following trust funds are hereby created, to 5 be administered by the Department of Health: 6 (f) Social Services Block Grant Trust Fund. 7 1. Funds to be credited to the trust fund shall 8 consist of federal social services block grant funds. Funds 9 shall be used for the purpose of providing health care and support services to department clients and for other such 10 purposes as may be appropriate and shall be expended only 11 12 pursuant to legislative appropriation or an approved amendment to the department's operating budget pursuant to the 13 14 provisions of chapter 216. 2. Notwithstanding the provisions of s. 216.301 and 15 pursuant to s. 216.351, any balance in the trust fund at the 16 17 end of any fiscal year shall remain in the trust fund at the 18 end of the year and shall be available for carrying out the 19 purposes of the trust fund. 20 3.
