- (d) Has the ability to communicate in the English language, which may be determined by an examination given by the department.
- (2) Each applicant who passes the examination and provides proof of graduation from an approved nursing program, or its equivalent as determined by the board by rule, shall, unless denied pursuant to s. 464.018, be entitled to licensure as a registered professional nurse or a licensed practical nurse, whichever is applicable.
