The bill would amend the disqualification provision for voluntarily leaving work by adding to the meaning of "good cause" the condition of being a victim of domestic violence which results in separation from work.

The bill provides an effective date of July 1, 2000.

## **B. PRESENT SITUATION:**

Section 443.101(1)(a)1., Florida Statutes, provides that an individual who has voluntarily quit employment is subject to disqualification from receiving unemployment compensation benefits for the full period of unemployment next ensuing after he or she has left work and until such individual has earned income equal to at least 17 times the weekly benefit amount of the claim. However, if the individual leaves work with "good cause," he or she is not subject to disqualification. The term "good cause" is defined as cause attributable to the employing unit or which consists of illness or disability of the individual requiring separation from his or her work.

## C. EFFECT OF PROPOSED CHANGES:

The bill would amend s. 443.101(1)(a)1., F.S., allowing victimization through domestic violence as a condition of "good cause" for separation from employment.

VI.	. AMENDMENTS OR COMMITTEE SUBSTITUTE CHANGES:				
	On March 21, 2000, the Committee on Business Development and International Trade adopted one amendment. The amendment provides that an individual, who is separated from work due to circumstances directly resulting from domestic violence, must establish satisfactory proof, including corroborating evidence. The proof may include, but is not limited to one of the following: a restraining order or equitable relief, a police record documenting domestic violence proof of conviction of the domestic violence perpetrator, medical documentation of domestic violence, certification from a certified domestic violence specialist, or other documentation from a professional who assisted the victim in dealing with domestic violence. Further, the amendment designates the Temporary Assistance to Needy Families block grant as the source of funding for payments for unemployment compensation claims regarding domestic violence.
