(1) The Department of Veterans' Affairs 25 Tobacco Settlement Trust Fund within the department, FLAIR 26 number 50-2-122, which is to be terminated pursuant to Section 27 19(f), Article III of the State Constitution on July 1, 2003, 28 is re-created. 29 (2) All current balances of the trust fund are carried 30 forward, and all current sources and uses of the trust fund 31 are continued.
