I. SUMMARY:

HB 735 redesignates the "Windley Key Fossil Reef State Geological Site" located in the Village of Islamorada, as the "Alison Fahrer - Dagny Johnson Fossil Reef State Geological Site".

*NOTE:*

At its meeting the Committee on Environmental Protection adopted a strike-all amendment to this bill, which is traveling with the bill. The amendment redesignates the "Key Largo Hammocks State Botanical Site" in Key Largo, Monroe County, Florida as the "Dagny Johnson Key Largo Hammock State Botanical Site."

The original bill, and the amended bill provide effective dates of upon becoming law.

There appears to be no direct fiscal impact on state or local governments.

B. PRESENT SITUATION:

Windley Key was sold in 1908, by the Russell family to the Florida East Coast Railway. The key's quarries were used to supply rock in the construction of the Flagler's Overseas Railroad. In 1912, after the railway's completion, "Keystone" was quarried at Windley Key until the 1960s. Windley Key is the highest of the chain of islands formed of Key Largo Limestone. The state maintains this site located in the Village of Islamorada so that visitors may study this ancient fossilized, coral reef formation and view the historic remains of the quarrying activities.

C. EFFECT OF PROPOSED CHANGES:

This bill redesignates the Windley Key Fossil Reef State Geological Site, as the "Alison Fahrer-Dagney Johnson Fossil Reef State Geological Site."

*NOTE:* The strike everything amendment would redesignate the Key Largo Hammocks State Botanical Site in Key Largo, Monroe County, Florida as the "Dagney Johnson Key Largo Hammock State Botanical Site."
