On page 3, between lines 22 and 23,

insert:

Section 2. Present paragraphs (e), (f), (g), and (h) of subsection (3) of section 110.123, Florida Statutes, are redesignated as paragraphs (f), (g), (h), and (i), respectively, and a new paragraph (e) is added to that subsection, to read:

110.123 State group insurance program.--

(3) STATE GROUP INSURANCE PROGRAM.--

(e) The Department of Management Services or the Division of State Group Insurance may not prohibit or limit any properly licensed insurer, health maintenance organization, prepaid limited health services organization, or insurance agent from competing for any insurance product or plan purchased, provided, or endorsed by the department or the division on the basis of the compensation arrangement used by the insurer or organization for its agents.
