1 A bill to be entitled
2 An act relating to Lehigh Acres Fire Control
3 and Rescue District, Lee County; providing
4 legislative intent; providing for codification
5 of the special acts relating to the district
6 pursuant to s. 191.015, F.S.; codifying,
7 reenacting, and amending all prior special
8 acts; re-creating the district; correcting
9 district boundaries; providing status as an
10 independent special district and purpose;
11 providing for amendment of the charter;
12 providing for election of the governing board;
13 providing for officers and powers; providing
14 for ad valorem taxation and non-ad valorem
15 assessments; providing planning requirements;
16 providing for annual review of user fees for
17 emergency medical services; providing for
18 policies and regulations; providing for public
19 disclosure; authorizing per diem; providing for
20 the budget; revising provisions relating to
21 taxing authority, assessment and collection of
22 taxes, financing, tax collector's
23 responsibility, expenses, treasurer's bond, and
24 financial reports; providing for liberal
25 construction; repealing all prior special acts
26 relating to the district; providing
27 severability; providing an effective date.
28
29 Be It Enacted by the Legislature of the State of Florida:
30
31

1 Section 1. Pursuant to section 191.015, Florida
2 Statutes, this act constitutes the codification of all special
3 acts relating to Lehigh Acres Fire Control and Rescue
4 District. It is the intent of the Legislature in enacting this
5 law to provide a single, comprehensive special act charter for
6 the district, including all current legislative authority
7 granted to the district by its several legislative enactments
8 and any additional authority granted by this act. It is
9 further the intent of this act to preserve all district
10 authority, including the authority to annually assess and levy
11 against the taxable property in the district a tax not to
12 exceed 3.5 mills on the dollar of assessed valuation, except
13 as provided in chapter 191, Florida Statutes, or chapter
14 97-340, Laws of Florida, as amended from time to time.

15 Section 2. Chapters 63-1546, 65-1825, 67-1633, 76-406,
16 79-499, 81-416, 81-417, 83-453, 85-444, 87-432, 90-387,
17 91-384, 94-456, and 96-460, Laws of Florida, and section 1 of
18 chapter 83-454, Laws of Florida, are codified, reenacted,
19 amended, and repealed as herein provided.

20 Section 3. The Lehigh Acres Fire Control and Rescue
21 District is re-created, and the charter for such district is
22 re-created and reenacted to read:

23
24 Section 1. Creation; Boundaries.--There is hereby
25 created and established the Lehigh Acres Fire Control and
26 Rescue District, hereinafter referred to as the district,
27 which shall include the following described lands, to wit:

1 The Southeast quarter of the Northeast quarter

15 which is also the South one-quarter corner of

17 feet along the South boundary of said Section
18 19 to the point of beginning of the lands
19 hereinafter described: From said point of
20 beginning go North 00°33'49" West 961.01 feet
21 to the Southerly U. S. Government easement line
22 of the Caloosahatchee River; thence North
23 00°33'48" West 90.00 feet, more or less, to the
24 actual South shore of the Caloosahatchee River;
25 thence Southerly and Westerly along the
26 meanders of said river to a point which lies
27 North 00°33'48" West of a point on the South
28 boundary of Section 19, said latter point being
29 623.7 feet from the point of beginning as
30 measured along the South boundary of Section
31 19; thence South 00°33'48" East 50.00 feet to

1 the Southerly U. S. Government easement line of
2 the Caloosahatchee River; thence South
3 00°33'48" East 578.75 feet to the South line of
4 Section 19; thence South 89°32'09" East along
5 the South line of Section 19 to the point of
6 beginning.
7
8 West half of: Beginning at the Northwest
9 corner of Section 30, Township 43 South, Range
10 27 East; thence running South 654 feet to
11 center of State Road No. 25 (now known as State
12 Road No. 80) thence Southerly 82°15'00" East
13 3,342 feet; thence Southerly 84°15'00" East
14 694.00 feet; thence North 1,239 feet to the
15 Northwest corner of the Northeast quarter of
16 the Northeast quarter of said Section 30;
17 thence West to the point of beginning.
18
19 Less: The East 35.8 feet of the parcel in
20 Section 19, Township 43 South, Range 27 East,
21 and the West 118.4 feet of the parcel in
22 Section 30, Township 43 South, Range 27 East,
23 said parcels as described in Deed recorded in
24 Official Record Book 95, page 135-136, of the
25 public records of Lee County, Florida.
26
27 A tract or parcel of land lying in the West
28 half of Section 30, Township 43 South, Range 27
29 East, in Lee County, Florida, described as
30 follows: From a concrete monument marking the
31 Southeast corner of Lot 5 of Unit No. 2 Pine

1 Creek Acres, as recorded in Plat Book 10 at

11 468.7 feet; thence run West parallel to said
12 center line for 678.0 feet more or less to the
13 waters of Hickey's Creek; thence run Southerly
14 and Easterly along the meanders of said creek
15 to an intersection with a line parallel to and
16 710.00 feet, measured on a perpendicular, from
17 said center line of said railroad; thence run
18 East on said parallel line for 567.00 feet more
19 or less to a point of beginning.

21 The following described lands in the West half
22 of Section 30, Township 43 South, Range 27
23 East: From concrete monument marking the
24 Southeast corner of Lot 5, Unit 2, Pine Creek
25 Acres, according to plat thereof as recorded in

28 of said Lot 5 to the Southwest corner of said
29 lot; thence North along the West line of said
30 Lot 5 to the South line of Pine Boulevard, as

3 marking the Northeast corner of Lot 92 of said
4 Unit 2, Pine Creek Acres; thence Southerly

7 Southeasterly following the center line of said
8 Hickey's Creek to a point which is 1,178.7 feet
9 North of the center line of the former SAL
10 Railway and said point being the Northwest
11 corner of lands conveyed to Paul W. Grubbs and
12 wife, Naomi G. Grubbs, by deed recorded in Deed
13 Book 274 at page 463, public records of Lee
14 County, Florida; thence East parallel to the
15 center line of SAL Railway 678.00 feet, more or
16 less, to a point which is 2,418.00 feet East,
17 measured on a perpendicular from the West line
18 of said Section 30; thence North 00°56'00" West
19 2,063.10 feet to the point of beginning.

21 The Northeast quarter of the Northeast quarter
22 of the Northeast quarter, and the Southwest
23 quarter of the Northwest quarter of the

6 line, 660.00 feet; thence Northerly 660.00
7 feet; thence Westerly and parallel to the said
8 Railroad right of way line to the intersection
9 with a line parallel to and 2,418.00 feet from
10 the West line of the Northwest quarter of the
11 said Section 30; thence North 00°56'00" West
12 along the said line parallel to the West line
13 of the Northwest quarter Section 30 to a point
14 that is South 00°56'00" East, 223.86 feet from
15 the Southerly right of way line of State Road
16 80; thence North 89°35'20" East, 166.20 feet;
17 thence North 00°24'40" West, 203.00 feet to the
18 Southerly right of way line of said State Road
19 80; thence South 82°54'00" East, along said
20 right of way line 137.61 feet; thence South
21 00°24'40" East, 237.58 feet; thence North
22 89°35'20" East, 209.19 feet; thence South
23 00°24'40" East, 918.16 feet; thence North
24 89°35'20" East, 420.00 feet; thence North
25 00°24'40" West, 1,069.39 feet to the Southerly
26 right of way line of State Road 80; thence
27 Southeasterly along the arc of a curve to the
28 right, having a radius of 17,113.74 feet and a
29 delta angle of 01°46'00"; an arc distance of
30 188.21 feet to the end of said curve; thence
31 continue along said right-of-way line South

1 81°08'00" East, 456.59 feet to its intersection
2 with the East line of the Northwest quarter of
3 the Northeast quarter of said Section 30;
4 thence South 00°24'40" East along the East line
5 of the West one-half of the Northeast quarter
6 of said Section 30 to a point 129.00 feet South
7 00°24'40" East from the Northwest corner of the
8 Southeast quarter of the Northeast quarter;
9 thence South 89°41'55" East, and parallel to
10 the North line of the said Southeast quarter of
11 the Northeast quarter of said Section 30,
12 337.00 feet; thence North 00°24'40" West to the
13 right of way line of State Road 80; thence
14 South 81°08'00" East along said right of way
15 line to its intersection with the East line of
16 said Section 30; thence South 00°08'33" East,
17 along the East line of said Section 30 to the
18 Southeast corner of the Northeast quarter;
19 thence continue South 00°32'10" East, 2,643.68
20 feet to the Southeast corner of said Section;
21 thence South 89°58'04" West, along the South
22 line of Section 30, 2,637.54 feet to the
23 Southwest corner of the Southeast quarter;
24 thence continue North 89°55'20" West, 2,643.03
25 feet to the Southwest corner of said Section 30
26 and the point of beginning, less a strip of
27 land 100.00 feet wide and lying in the South
28 one-half of said Section 30, and being the old
29 SAL Railroad right-of-way, less the West 200.00
30 feet of said Section 30 lying South of Hickey's
31 Creek, plus the following described parcel; in

1 Section 30, Township 43 South, Range 27 East,
2 begin at the intersection of the centerline of
3 Hickey's Creek with the North line of SAL
4 Railroad right-of-way; thence Easterly, 660.00

25 Lots 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13,
26 14, 15, 16, 17, 18, 19, 20, 21, 22, 25, 26, 29,
27 30, 31, 32, 33 and 34, Unit No. 2, Pine Creek
28 Acres, according to the map or plat thereof on
29 file and recorded in the office of the Clerk of
30 Circuit Court of Lee County, Florida, in Plat
31 Book 10, at page 74.

2 Beginning at the point of intersection of the
3 south right of way line of State Road No. 80
4 (Palm Beach Boulevard) with the West line of
5 said Section 30 run South 82°54'00" East along
6 said South right of way line (75 feet from the
7 center line) for 450.2 feet to the
8 northwesterly corner of Lot 9 of said Unit No.
9 1; thence run South 07°06'00" West along the
10 westerly line of said Lot 9 for 200.00 feet;
11 thence run South 82°54'00" East along the
12 southerly line of Lots 9 and 10 for 100 feet;

26 Section 2. Status and purpose.--The Lehigh Acres Fire
27 Control and Rescue Service District, an independent special
28 district, is organized and exists for all purposes set forth
29 in this act, chapter 97-340, Laws of Florida, and chapters 189
30 and 191, Florida Statutes. To the extent of any conflict
31 between this act and chapter 97-340, Laws of Florida, those

1 provisions of chapter 97-340, Laws of Florida, shall supersede
2 this act.

3 Section 3. Creation of district; amendment of
4 charter.--The district was created by special act of the
5 Legislature in 1963. Its charter may be amended only by
6 special act of the Legislature.

7 Section 4. Governing body.--The governing authority of
8 the district shall be a board composed of five resident
9 electors of the district elected as provided in chapter
10 97-340, Laws of Florida, and chapter 191, Florida Statutes, as
11 they may be amended from time to time.

12 Section 5. Officers; powers.--

13 (1) Within 60 days after the election and
14 qualification of members of the board, such members shall meet
15 and elect from the membership a president, a secretary, and a
16 treasurer; provided, however, the same member may be both
17 secretary and treasurer. The district shall have, and the
18 board may exercise, all those general and special powers and
19 duties prescribed in chapter 191, Florida Statutes, and
20 chapter 97-340, Laws of Florida, as they may be amended from
21 time to time.

22 (2) The district shall have, and the board may
23 exercise, all powers, functions, and duties set forth in
24 chapters 189 and 191, Florida Statutes, and chapter 97-340,
25 Laws of Florida, as they may be amended from time to time,
26 regarding ad valorem taxation, bond issuance, other
27 revenue-raising capabilities, budget preparation and approval,
28 liens and foreclosure of liens, use of tax deeds and tax
29 certificates as appropriate for non-ad valorem assessments,
30 and contractual agreements. The district may be financed by
31 any method established in this act, chapter 189 or chapter

1 191, Florida Statutes, chapter 97-340, Laws of Florida, or any
2 other applicable general or special law, as they may be
3 amended from time to time.

4 (3) The methods for assessing and collecting non-ad
5 valorem assessments, fees, or service charges shall be as set
6 forth in chapters 170, 197, 189, and 191, Florida Statutes,
7 and chapter 97-340, Laws of Florida, as they may be amended
8 from time to time.

9 (4) The district's planning requirements shall be as
10 set forth in this act, chapters 189 and 191, Florida Statutes,
11 and chapter 97-340, Laws of Florida, as they may be amended
12 from time to time.

13 (5) The district's geographic boundary limitations
14 shall be as set forth in this act.

15 (6) The district is authorized to charge user fees for
16 emergency medical services. The fee schedule shall be
17 determined by the board. These fees shall be reviewed on an
18 annual basis, and any increase or decrease from the existing
19 fee schedule shall become effective October 1 of each year.

20 Section 6. Policies and regulations.--The board is
21 hereby authorized and empowered to adopt policies and
22 regulations for fire control, prevention of fires, and
23 emergency rescue work within the district. Such policies and
24 regulations, after being made by the board and copies thereof
25 signed by the president and secretary, and posted in at least
26 three public places within said district, one of which must be
27 the fire station or such similar place wherein the
28 firefighting equipment is normally kept, within 10 days after
29 said policies and regulations are adopted by the board, shall
30 have force and effect as law.

31

1 Section 7. Public disclosure.--Requirements for
2 financial disclosure, meeting notices, reporting, public
3 records maintenance, and per diem expenses for officers and
4 employees shall be as set forth in chapters 112, 119, 189,
5 191, and 286, Florida Statutes, and chapter 97-340, Laws of
6 Florida, as they may be amended from time to time.

7 Section 8. Budget.--For the purposes of carrying into
8 effect this act, the board shall annually prepare, consider,
9 and adopt a district budget pursuant to the applicable
10 requirements of chapter 200, Florida Statutes, as it may be
11 amended from time to time.

12 Section 9. Taxing authority.--The board shall fix and
13 cause to be levied on all property of said district, real and
14 personal, a millage sufficient to meet the requirements of the
15 adopted budget, provided, however, 3.5 mills is the maximum
16 that can be levied in any one year, except as provided in
17 chapter 191, Florida Statutes, or chapter 97-340, Laws of
18 Florida, as amended from time to time.

19 Section 10. Assessment and collection of taxes;
20 financing.--Taxes herein provided for shall be assessed and
21 collected in the same manner and form as provided for the
22 assessment and collection of county taxes.

23 Section 11. Tax collector's responsibility.--When such
24 taxes as herein provided for shall have been collected by the
25 tax collector of Lee County, he or she shall, on or before the
26 10th day of each month, report to the secretary of the board
27 the collections made for the preceding month and remit the
28 same from such treasurer. Thereupon the tax collector shall be
29 relieved from all other and further liability as to the amount
30 so paid the treasurer of the board.

31

1 Section 12. Expenses.--All warrants for the payment of
2 labor, equipment, and other expenses of the board, and in
3 carrying into effect this act and the purpose thereof, shall
4 be payable by the treasurer of the board on accounts and
5 vouchers approved by the board.

6 Section 13. Treasurer's bond.--The treasurer of the
7 board, when entering upon his or her duties, shall give a good
8 and sufficient bond to the Governor of Florida in the sum of
9 \$5,000 for the faithful performance of his or her duties as
10 such treasurer.

11 Section 14. Financial reports.--The treasurer shall,
12 on or before the 10th day of April and 10th day of October
13 each year, make his or her semiannual report of receipts and
14 expenditures of the funds of said district to the board. Such
15 report shall be in writing, setting forth the amount of money
16 received, from whom received, and itemized amounts of
17 expenditures and to whom paid and for what such payment is
18 made. At the time of making such report to the board, the
19 treasurer shall also file a copy of such report with the Board
20 of County Commissioners of Lee County.

21 Section 15. Construction.--This act shall be construed
22 as a remedial act and shall be liberally construed to promote
23 the purpose for which it is intended.

24
