The Department of 22 Management Services shall include in its budget request its 23 specific recommendations for a salary and benefits policy for state employees. However, no state agency shall submit its 24 25 complete legislative budget request, including all supporting forms and schedules required by this chapter, later than 26 27 September 15 of each year. 28 Section 2.
