(7) "Division" means the Division of Bond Finance of 18 19 the State Board of Administration. 20 (8) "Express written consent" means prior express 21 written consent given in the form of a resolution adopted by a board of county commissioners. 22 "Federal agency" means and includes the United 23 (9) 24 States, the President of the United States, and any department of, or corporation, agency, or instrumentality created, 25 26 designated, or established by, the United States. 27 332.203 Airport authority; formation; membership.--(1) Any county which has a population of more than 2.1 28 million people shall at the countywide election hold a 29 30 referendum in which the electors shall decide whether to form an airport authority, which shall be an agency of the state, 31 2

Similar proposals shall be reviewed and acted on by the 11 12 authority in the order in which they were received. An 13 additional airport may only be constructed under this paragraph with state and federal approval, and with the prior 14 15 express written consent of the board of county commissioners of each county located within the geographical boundaries of 16 17 the authority. 18 (3) The use or pledge of any portion of county tax 19 funds may not be made without the prior express written 20 consent of the board of county commissioners of each county 21 located within the geographic boundaries of the authority. For this reason, an authority is not required to pay any taxes or 25 26 assessments of any kind or nature whatsoever upon any property 27 acquired by it or used by it for such purposes or upon any 28 revenues at any time received by it. The bonds issued by or on 29 behalf of an authority, their transfer, and the income 30 therefrom, including any profits made on the sale thereof, are exempt from taxation of any kind by the state or by any 31
