Section 110.1228, Florida Statutes, is 17 created to read: 110.1228 Participation by small counties, small 18 19 municipalities, and district school boards located in small 20 counties .--21 As used in this section, the term: "District school board" means a district school 22 23 board located in a small county. "Small municipality" means an incorporated 24 municipality that has a population of 12,500 or fewer 25 26 according to the most recent decennial census. "Small county" means a county that has a 27 28 population of 100,000 or fewer according to the most recent decennial census. 29 30 The governing body of a small county or small municipality or a district school board may apply for

participation in the state group health insurance program authorized in s. 110.123 and the prescription drug coverage program authorized by s. 110.12315 by submitting an application along with a \$500 nonrefundable fee to the department.

- (3) As a prerequisite to applying for participation in the state group health insurance program and the prescription drug coverage program, a small county, small municipality, or district school board must adopt an ordinance or resolution ratifying such application to the state group health insurance program and the prescription drug coverage program.
- (4) If the department determines that a small municipality, small county, or district school board is eligible to enroll, the small municipality, small county, or district school board must agree to the following terms and conditions:
- (a) The minimum enrollment or contractual period will be 3 years.
- (b) It must pay to the department a monthly administrative fee not to exceed \$2.75 per enrollee per month.
- (c) Termination of participation of a small municipality, small county, or district school board requires written notice 1 year before the termination date.
- (d) If participation is terminated, a small municipality, small county, or district school board may not reapply for participation for a period of 2 years.
- (e) If a small county, small municipality, or district school board employer fails to make the premium payment required by this chapter, the Department of Revenue or the Department of Banking and Finance shall, upon the request of the Department of Management Services, deduct the amount owed

by the employer from any funds to be distributed by it to the small county, small municipality, or district school board.

The amounts so deducted shall be transferred to the department for further distribution to the trust funds in accordance with this chapter.

- (f) The small municipality, small county, or district school board shall furnish the department information requested by the department which the department considers necessary to administer the state group health insurance program and the prescription drug program.
- (5) The provisions of ss. 624.436-624.446 do not apply to the State Group Insurance Program or to this section.
- (6) The Department of Management Services may adopt rules to administer this section.

Section 2. This act, except for this section, which shall take effect upon becoming a law, shall take effect October 1, 2001, if the Department of Management Services receives the favorable letters described in section 1 of chapter 2000-363, Laws of Florida, before that date. If the Department of Management Services receives such favorable letters on or after October 1, 2001, and before October 1, 2002, this act shall take effect October 1, 2002, and if the department receives such favorable letters on or after October 1, 2002, this act shall not take effect.

SENATE SUMMARY

Provides conditions under which small municipalities and small counties, as defined, and school districts of small counties, may participate in the state's group insurance program and prescription drug program.
